# 112-19 DECLARATIONS OF INTEREST RELATING TO ITEMS ON THE AGENDA - Clir G.

Braund declared an interest in items 121-19 Broadband and 124-19 Section 137 Under Fives due to her capacity as Treasurer of Landulph Memorial Hall. It was agreed that Cllr Braund should stay in the room to answer questions but would not take part in the votes.

### 113-19 TO CONFIRM THE MINUTES OF THE PREVIOUS MEETING (21.10.2019)

The minutes of 21.10.2019 were agreed.

### 114-19 MATTERS ARISING FROM THE MINUTES - none

- a) With reference to minute no. 108-19, it was reported that the local police had provided good support following the vandalism incident on The Coombe, and it was noted that, due to this incident, Landulph Parish now has a crime figure.
- b) With reference to minute no. 92-19a), planning application <u>PA19/06644</u> | Replacement of existing hip roof and bay window to first floor rear tenement with new glazed gable end roof with Juliette balcony | Warleigh View Cottage Fore Street Cargreen PL12 6PA the Parish Council has since agreed with the revised application, as changes were made as requested by the Parish Council.
- c) The Chairman welcomed Marc Shirlaw as the new press representative.
- d) Following a question during the public forum, the Chairman gave an explanation regarding Section 137 funding, stating that it was a statutory system to enable donation from the Parish Council precept fund.

# 115-19 PLANNING - TO CONSIDER PLANNING APPLICATIONS RECEIVED:

<u>PA19/09019</u> | Proposed Stables, store and hard standing and sand school. | Trelevans Landulph Saltash Cornwall PL12 6ND

This item was discussed and unanimously agreed with the following provisions:

- Use by applicant only not for commercial use
- No external lighting without additional planning application
- Ensure adequate width to neighbouring footpath.

# 116-19 NEIGHBOURHOOD PLANNING (STANDING ITEM)

A list has been compiled of issues raised during the development of the plan but not required to be part of the plan. It was felt that this list, which had categories on: Traffic & Transport / Communication & Business / Recreation, should be reviewed routinely as part of all discussions and undertake actions as and when possible.

# 117-19 TREES (STANDING ITEM)

The Parish Tree Warden praised a young member of the Landulph School who was awarded a Silver Acorn at a recent event by The Tree Council in conjunction with Cornwall Council for growing the best sapling from an acorn.

The Parish Tree Warden explained the proposal for a Community Copse which would be planted in a 1/3 acre of rough ground in a corner of The Searle Memorial Field, known as Saltash Cricket Ground. The plan would be to plant 12 mixed indigenous samplings donated by The Woodland Trust and the community. Volunteers from the community would be required to assist with this project. The proposal is to be submitted to Saltash Cricket Club for their consideration and a follow up meeting to be arranged. **[ACTION: Clir P Braund and Tree Warden].** 

# 118-19 PENYOKE RECREATION GROUND REFURBISHMENT, ANNUAL INSPECTION REPORT, ROLLING PROGRAMME (STANDING ITEM)

Cllr M. Dennis advised that Pillaton Play Area has had to close, as it has been condemned due to safety concerns regarding rotting equipment. This highlights the importance of the ongoing maintenance of Penyoke Play Area. It was noted that Penyoke Play area has been given a high rating on a Google review of "things for children to do around the Saltash area". **[ACTION: Clerk to add link to the Parish Council website].** 

# 119-19 PENYOKE RECREATION GROUND BANK MAINTENANCE UPDATE

The Environment Agency works are ongoing and scheduled to be finished in December. The bank will then need the grass to be cut in preparation for the wild flower project.

### 120-19 DEFIBRILLATOR

Following a recent incident when access in an emergency situation to the Defibrillator was required it was found to be difficult to open the cabinet. Cllr Worth produced a short video that was circulated on Landulph Innit showing how to open the cabinet. The code required to facilitate opening the cabinet in now in place by the machine. It was agreed to arrange a refresher training session for the community. **[ACTION: Parish Clerk].** 

# 121-19 BROADBAND – REVIEW OF CHARGES AND DISCUSSION ON FUNDING FROM JULY 2020 ONWARDS

A meeting was held with Memorial Hall Committee to discuss the cost of Broadband, as a previous grant covering the Broadband fees expires in April 2020. A proposal was made to the Landulph Hall Management Committee that the Parish Council will fund half the cost of Broadband charge.

# 122-19 EMERGENCY PLAN UPDATE

# [ACTION: Cllr Worth to arrange another Emergency Plan meeting].

Concern re the road from the Coombe to Tinnell being overgrown and no longer passable for traffic if need in an emergency situation. Cornwall Council has previously been approached with regard to this issue but in view of the current Emergency Plan it was felt that this concern should be raised again.

# [ACTION: Parish Clerk to contact Cornwall Council to ask for new signage stating 'Road Unsuitable for Motor Vehicles'].

# 123-19 FINANCIAL UPDATE, INCLUDING RESERVES

A short discussion suggested that a possible revision of presentation may make this document more useful. Also, clarification required on the breakdown of the monies received from the filming. [ACTION: Cllr Worth / Parish Clerk].

### 124-19 SECTION 137 FUNDING APPLICATION FROM LANDULPH UNDER FIVES

Landulph Under 5's have a current shortfall of £3k, urgent action is required to prevent closure of this long established group. They have also approached Botus Fleming Parish Council for any additional financial help that may be possible, this is an agenda item for their meeting on 27th November. Landulph Parish Council has been approached to commit funds from Section 137 to help the group continue while they increase marketing and their endeavours to increase numbers, that in turn would increase income. After serious discussion the Parish Council unanimously agreed to support this application, and agreed funding this amount for this year and next (noting that Cllr G Braund had declared an interest in this decision and did not vote). Cllrs P. Braund and M. Dennis requested this is reviewed in a year.

It was RESOLVED to pay the maximum Section 137 funding for two years. To be reviewed in November 2020. This will come from the Parish Council reserve funds. It is hoped this will provide the Under Fives with some stability so that they can increase numbers and become financially stable. **[ACTION: To be reviewed November 2020].** 

### 125-19 PHONE LINES IN THE PARISH

An ongoing problem with phone landlines in the parish was reported. **[ACTION: Cllr Worth to contact BT].** 

### 126-19 PRECEPT PROPOSALS 2020-21

It was RESOLVED to defer this until the December Parish Council meeting.
