# 66-21 PENYOKE RECREATION GROUND REFURBISHMENT, ANNUAL INSPECTION REPORT, ROLLING PROGRAMME / GRASS BANK (STANDING ITEM)

Cllr Dennis reported that we are currently 3 months overdue for the annual inspection and that regular reminders to the Play Inspection Company had been made and would continue. [ACTION: Clerk to recontact Play Inspection Co].

## 67-21 FOOTPATHS UPDATE (STANDING ITEM)

Cllr Tagg reported 3 separate issues with footpaths:

- a) Footpath from Salter's Mill to Haye Farm: broken stile. This was reported via C.C. database but reply stated that they are currently only concentrating of issues that cause a serious health and safety risk. The farmer has offered to repair this when he has some time.
- b) Footpath from Penyoke Mill around the foreshore is blocked by fallen trees.
- c) Footpath at Paradise Lane is very boggy.

  Footpaths are a categorised. Gold C.C. will cut 2x per year, Silver x1 per year, bronze not at all.

  Adjoining landowners are responsible for cutting side vegetation & trees.

Cllr Tagg will encourage parishioners to continue to report via C.C. database and monitor responses and report same to Cllr Worth for him to follow up.

## 68-21 CLIMATE CHANGE ACTION GROUP (STANDING ITEM)

Ongoing monthly article in Landulph Newsletter.

Recent climate change survey of parish had 35 responses, which amounts to approx. 12% of households responded. These responses and comments are currently being analysed to ensure future programmes and initiatives are relevant to requirements.

Cllr Dennis proposed that LPCAG should have a stall costing £10 at Landulph Craft Fair at LMH 20<sup>th</sup> Nov, seconded by Cllr Tagg.

Group currently investigating subjects and speakers for winter talks. Cllrs Worth, Tagg and Dennis attended the first meeting of Cornwall Gateway Climate Change Working Group.

Cornwall Council has won the Leadership in Responding to the Climate Emergency category in the Municipal Journal Local Government Achievement Awards.
